

Friends of Trees was founded by Richard Seidman in 1989 to build community and to improve the health of the environment and the lives to those who call the urban spaces of the Pacific Northwest home. Since our inception, we have supported the planting of over half a million trees and native plants.

Friends of Trees is a member of Alliance for Community Trees, Oregon Community Trees, and EarthShare Oregon. We meet all 20 Better Business Bureau Wise Giving Alliance Standards for Charities. We have been named among the top 100 Best Nonprofits to work for and Best Green Workplaces by Oregon Business for five years running. VOLUNTEER + OUTREACH

The Volunteer & Outreach program recruits, organizes and manages thousands of volunteers for Friends of Trees. More than **6,000 individuals volunteered** with Friends of Trees throughout the planting season. This is the largest number

of people who have partnered with our organization in its history. Collectively **our volunteers worked 36,776 hours in 18 different roles** from phone banking to planting to inspecting the health of our trees. This collective support is priceless!





NEIGHBORHOOD TREES

The Neighborhood Trees program improves the health of our communities and urban tree canopy by partnering with volunteers and residents to plant trees in Portland, Vancouver, Beaverton, Eugene, Oregon City, Springfield, and Salem neighborhoods. This season we planted 3,798 street, yard and school trees.

The NT program and our partners planted 138 different varieties of trees in 121 neighborhoods throughout the Pacific Northwest. Once the trees are in the ground, dedicated community volunteers track the health of young trees. Follow up care continues to be a priority as we strive to create a healthier urban forest for the future. We further developed our Community Tree Care program by pruning over 1,500 young street trees.





GREEN SPACE

The Green Space team works in urban natural areas to restore and improve native habitats. These sylvan locations provide a vital resource for our urban invertebrates, birds, and mammals as well as an important area for humans to connect directly with nature.



Thanks to partners and volunteers, the Green Space program planted 47,864 native trees, shrubs, and herbaceous plants in 41 locations. We also continued our work improving greenbelts in public spaces and along roadways with work adjacent to Eugene's Northwest Expressway, planting in ODOT Region 2, and continuing work on the award winning I-205 planting project.






