Note, re: operating deficit (form 990 follows)

Friends of Trees experienced a substantial end-of-year budget deficit in FY2023-2024 due to a combination of timing-related funding issues and unexpected cost increases. FY2024-2025 was dedicated to strengthening our budget position and improving financial forecasting moving forward, which we have successfully done. We are pleased to report that our efforts, combined with the eventual receipt of delayed grant funds and the scheduled completion of our multi-year projects, resulted in ending FY2024-25 with a surplus.

1. Two of our largest funding sources in recent years were structured as two-year, one-time agreements. While the funding for these awards was received in prior fiscal years, the actual work and spending timelines extended beyond what was originally anticipated and budgeted. This meant that although funds had been received in advance, the work was spread out over a longer period, delaying the recognition of new funds tied to the completion of existing deliverables. As a result, we operated with fewer new revenue opportunities in the affected fiscal year, while continuing to bear the operational costs of ongoing projects.
2. We were awarded a large federal coalition grant that was integral to our projected budget. It was necessary to begin work immediately to put systems and staff into place to deliver on this award. However, the actual disbursement of initial grant funds didn't arrive until 9 months post-award, despite our incurring costs in the interim in order to deliver on the grant for ourselves and our partners. This substantial delay created a gap between when the funding was budgeted to arrive and when it was actually received, contributing to the mismatch between revenues and expenses for the year.

Additionally, the cost of operations increased considerably during this period. Rising expenses for materials, supplies, staff, and other essential inputs meant that previously negotiated contracts no longer fully covered the costs required to deliver our work. These inflationary pressures further exacerbated the financial strain.

Despite these challenges, we took decisive steps to stabilize our financial position. We implemented a lean operating budget, eliminated non-essential spending, and identified cost-saving measures wherever possible. We view this experience as a valuable learning opportunity and have since improved our financial forecasting and grant management processes to better account for timing variances and cost fluctuations. We remain committed to our mission and to responsible stewardship of the resources entrusted to us.
